#### P.P.G.O DOOR DISPLAYRULES

The purpose of these rules is to help ensure the Professional Photographers of Greater Omaha and it's members are seen by the public in a consistently tasteful and professional manner when on public display. These rules are not intended to dictate to members any particular photographic or professional style.

- 1. Each active member may assemble one 3'x6' "Nim-Lok" brand panel set, attached to a common center pole with up to two other members or free standing if no other member's panels are available. This "normal" configuration may be modified as the display situation or location dictates.
- 2. Participating members may attach to their respective panels, photographs of their choosing, so long as these photographs and their mounts are of professional quality and appearance. The subject matter of these photographs will be of the member's own choosing unless the displaying members have in advance, agreed upon a common theme or themes. Because of the "family nature" of the display, nude images will not normally be acceptable and will be disallowed. Exceptions to this rule will be judged on a case by case basis, but in all likelihood would include infant, or infant/mother portraits. The displayed images or their mounts shall not extend beyond the outside edges of the panel set. Displayed photographs may bear the member's signature, or an embossed or imprinted logo of comparable size. No business cards may be placed on the photograph in order to identify the maker.
- 3. One 3"x6" studio identification plate must be attached to the member's panel set. This plate may be made of either plastic or metal but must have a brushed chrome or aluminum finish with black letters. Only member's logo, address, phone or PPof A credentials may appear on the plate.
- 4. Business card holders may be attached to the panel set. Business cards or color wallet cards may be used. The card may include studio name, logo, address, phone, credentials, trademarks or "catchy phrases". Cards may describe a specific type of photography, style, background, etc. when in good taste and not offering a price break or special offer. Price lists, giveaways, special promotions or pamphlets are not allowed on the panels, and may not be distributed by Members or their representatives in person in the vicinity of the display.
- 5: Set up times will be followed without exceptions. Take down times other than those scheduled will not be allowed. Displayers can arrange to have his/her exhibit taken down by another photographer, but only at the designated dates and times.

Set Up Time: Monday, 8:00 A.M. - 8:30 A.M.

Any members not being set up and out of the mall by 9:00 A.M. on Monday morning, will not be allowed to display for the week of that display. Any member setting up late will lose display privileges for the rest of the calendar year without refund of any paid display fees.

Take Down Time: Sunday within, but not prior to , 1/2 hour after the mall closes.

Members who do not take down or make arrangement in advance with someone else to take down their display, will pay a \$25.00 take down fee to PPGO. The member in question will not be allowed to further display with PPGO until all late fees have been paid to the PPGO treasurer.

### P.P.G.O DOOR DISPLAYRULES (Continued)

- 6. Members may change their photographs during the exhibit **before** or after mall hours only. Members may not rearrange or move panels to other areas within the display. No exceptions.
- 7. Any disputes regarding violations of these display policies will be settled by the PPGO President or his/her representative by removing the image/images in violation of the PPGO door display rules and informing the studio in violation by phone the same day. The studio in violation may replace the image/images in question with different images before or after mall hours (see rule 6).
- 8. Active members may seek to obtain a temporary variance of a specific display policy by petitioning the door display committee prior to the scheduled start of the display. The door committee (the door committee consists of the PPGO board members) may grant variances as it sees fit by a simple majority of its members.
- 9. Proposed changes in these policies will be reviewed by the door committee and voted upon by the active panel owners at a specifically scheduled meeting normally held within 60 days after the installation of PPGO Officers at the June meeting.
- 10. Only PPGO members in the "Active" category and in good standing may participate in an exhibit.
- 11. When multiple prints are mounted and hung as one unit, as in the case of a "wallet board" or similar treatment, no other studio logo may appear on the unit or the panel except those as designated previously in rules 2, 3 and 4.




